Consider the adoption of the following Ordinances:

#1 - AN ORDINANCE OF THE BOROUGH OF WEST CHESTER, CHESTER COUNTY, PENNSYLVANIA, AUTHORIZING AND ADOPTING THE EXTENSION OF POLICE COOPERATION AGREEMENT BETWEEN THE BOROUGH OF WEST CHESTER AND EAST BRADFORD TOWNSHIP FOR THE PERIOD OF JANUARY 1, 2018 THROUGH DECEMBER 31, 2018.

SUMMARY: This Ordinance would authorize Borough Council to enter a Police Cooperation Agreement with East Bradford Township for a one-year period. The Township shall pay to the Borough \$1,317,815 for police and administrative services provided during calendar year 2018.

#2 - AN ORDINANCE OF THE BOROUGH OF WEST CHESTER, CHESTER COUNTY, PENNSYLVANIA, AUTHORIZING INTERGOVERNMENTAL COOPERATION WITH THE TOWNSHIP OF EAST BRADFORD AND APPROVING A SEWER CAPACITY AGREEMENT BETWEEN THE BOROUGH OF WEST CHESTER AND EAST BRADFORD TOWNSHIP FOR A FIVE-YEAR TERM COMMENCING ON OR ABOUT NOVEMBER 14, 2017.

SUMMARY: This Ordinance would authorize Borough Council to enter a Sewer Capacity Agreement with East Bradford Township for a five-year term commencing on or about November 14, 2017. By the terms of the Agreement, the Borough agrees to receive, convey and treat sewage waste from properties in the Township of East Bradford for the fees and expenses as set forth in Article 8, titled "Charges and Payments"; Section 4.04; and a proportionate share of the cost of capital expenditures as set forth in Article 5.

#3 - TITLE & SUMMARY: AN ORDINANCE OF THE BOROUGH OF WEST CHESTER, CHESTER COUNTY, PENNSYLVANIA, AMENDING THE CODE OF THE BOROUGH OF WEST CHESTER, SPECIFICALLY CHAPTER 104 TITLED, "VEHICLES AND TRAFFIC", SECTION 104-29 TO PROHIBIT PARKING ON THE EAST SIDE OF BRADFORD AVENUE FROM HOOPES ALLEY TO MINER STREET; SECTION 104-45 TO ESTABLISH A HANDICAPPED PARKING SPACE AT 225 W. WASHINGTON STREET AND SECTION 104-45 TO REMOVE HANDICAPPED PARKING SPACES AT 218-220 W. BARNARD STREET AND 519 E. BARNARD STREET.

#4 - AN ORDINANCE OF THE BOROUGH OF WEST CHESTER, CHESTER COUNTY, PENNSYLVANIA, AMENDING THE CODE OF THE BOROUGH OF WEST CHESTER, SPECIFICALLY CHAPTER 94A TITLED, "STREAM PROTECTION FEE", TO AMEND SECTION 94A-7 TITLED "BILLING AND PAYMENT" AND SECTION 94A-11 TITLED "APPEALS".

SUMMARY: Amends Section 94A-7 of the Stream Protection Fee ordinance to amend the due date for the bills and amends Section 94A-11 to amend the procedure for filing an appeal.
