

ORDINANCE NO. - 2019

CHESTER COUNTY, PENNSYLVANIA

AN ORDINANCE OF THE BOROUGH OF WEST CHESTER, CHESTER COUNTY, PENNSYLVANIA, AMENDING THE CODE OF THE BOROUGH OF WEST CHESTER, SPECIFICALLY CHAPTER 104, TITLED "VEHICLES AND TRAFFIC," SECTION 104-45 TO REMOVE A HANDICAPPED PARKING SPACE AT 328 WEST GAY STREET; SECTION 104-44 TO ADD A NEW SUBPARAGRAPH B TO CREATE CAR SHARE PICK UP ZONES ON CERTAIN DESIGNATED STREETS THURSDAY, FRIDAY AND SATURDAY FROM 10:00 P.M. UNTIL 3:00 A.M.; SECTION 104-54 TO SUSPEND METERED PARKING ON THE FIRST FRIDAY OF THE MONTH YEAR ROUND FROM 5:00 P.M. UNTIL 12:00 A.M.; SECTION 104-67.A(6) TO PROVIDE FOR 10 METERED PARKING SPACES AT LOT NO. 6; AND SECTION 104-67.A(13) TO REMOVE 8 METERED PARKING SPACES AT GREENFIELD PARK AND ALLOW SUCH SPACES TO BE USED FOR PERMIT PARKING.

BE IT ENACTED AND ORDAINED, and it is hereby enacted by authority of the Council of the Borough of West Chester, as follows:

**SECTION 1.** Chapter 104 of the Code of the Borough of West Chester, titled, "Vehicles and Traffic," Section 104-45, titled, "Special purpose parking zones established; parking otherwise prohibited," is hereby amended **TO DELETE** the following:

Highway	Side	Location	Authorized Purpose or Vehicle
Gay Street	North	328 W. Gay St.	1 parking space for handicapped persons

**SECTION 2.** Chapter 104 of the Code of the Borough of West Chester, titled, "Vehicles and Traffic," Section 104-44 titled "Designation of taxi zones; parking otherwise prohibited" shall be retiled and amended as follows:

**§104-44. Designation of taxi zones and car share zones; parking otherwise prohibited.**

A. The following locations are hereby designated as taxi zones, and the parking of motor vehicles, except for taxis loading and unloading passengers, is prohibited at such locations:

<u>Highway</u>	<u>Side</u>	<u>Location</u>
Gay Street	North	East of High Street at sign as erected
Gay Street	South	East of Walnut Street at sign as erected

B. The following locations are hereby designated as car share zones from 10 p.m. until 3:00 a.m. on Thursday, Friday and Saturday, and the parking of motor vehicles, except for car share services loading and unloading passengers, is prohibited at such locations:

<u>Highway</u>	<u>Side</u>	<u>Location</u>
N. Walnut Street	East	Between Chestnut St and Gay Street
N. Church Street	Both	Between Prescott Alley and Gay Street
E. Market Street	South	Between Sharon Alley and S. Walnut Street
N. Darlington Street	West	Between Court House Alley and Gay Street

**SECTION 3.** Chapter 104 of the Code of the Borough of West Chester, titled, “Vehicles and Traffic,” Section 104-54 titled “Suspension of metered parking on first Fridays of months April through December from 5:00 p.m. until 10:00 p.m.” is hereby amended as follows:

**“§104-54. Suspension of metered parking on first Fridays from 5:00 p.m. until 10:00 p.m.**

The metered parking regulations set forth in §§104– 47, 104-48, 104-51, 104-52.1, 104-66, 104-67, 104-72 and 104-72.1 shall be suspended on the first Friday of the month between the hours of 5 p.m. until 12 a.m.”

**SECTION 4.** Chapter 104 of the Code of the Borough of West Chester, titled, “Vehicles and Traffic,” Section 104-67.A(6) titled “Parking time limits, charges and hours of operation for various parking lots” is hereby amended as follows:

“(6) Lot No. 6 is leased to the County of Chester on Monday through Friday from 8:00 a.m. to 5:00 p.m. except that 10 spaces shall be metered with parking meters where it shall be lawful to park at the parking meters between 8:00 a.m. to 10:00 p.m. on Mondays, Tuesdays and Wednesdays, between the hours of 8:00 a.m. to 12:00 midnight on Thursdays and Fridays, and between the hours of 5:00 p.m. to 12:00 midnight on Saturdays, at the rate set forth in a schedule of fees adopted by resolution of Borough Council.”

**SECTION 5.** Chapter 104 of the Code of the Borough of West Chester, titled, “Vehicles and Traffic,” Section 104-67.A(13) titled “Parking time limits, charges and hours of operation for various parking lots” is hereby amended as follows:

“(13) Six parking spaces at Greenfield Park shall be metered with parking meters where it shall be lawful to park at the parking meters between 8:00 a.m. to 10:00 p.m. on Mondays, Tuesdays and Wednesdays, between the hours of 8:00 a.m. to 12:00 midnight on Thursdays and Fridays, and between the hours of 5:00 p.m. to 12:00 midnight on Saturdays, at the rate set forth in a schedule of fees adopted by resolution of Borough Council. The remaining parking spaces at Greenfield Park shall be utilized for monthly permit parking, the cost of each monthly parking permit will be in accordance with the schedule of fees adopted by resolution of Borough Council.”

**SECTION 6. SEVERABILITY.** If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts hereof. It is hereby declared as the intent of Council of the Borough of West Chester that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included therein.

**SECTION 7. REPEALER.** All Ordinances or parts of Ordinances conflicting with any provision of this Ordinance are hereby repealed insofar as the same affects this Ordinance.

**SECTION 8. EFFECTIVE DATE.** This Ordinance shall become effective upon enactment as provided by law.
