AN ORDINANCE OF THE BOROUGH OF WEST CHESTER, CHESTER COUNTY, PENNSYLVANIA, AMENDING THE CODE OF THE BOROUGH OF WEST CHESTER, SPECIFICALLY CHAPTER 104 TITLED "VEHICLES AND TRAFFIC," SECTION 104-32 TO PROHIBIT PARKING ON CERTAIN PORTIONS OF WEST MARKET STREET AND POPLAR STREET DURING CERTAIN DAYS OF THE WEEK AND HOURS OF THE DAY; SECTION 104-45 TO REMOVE THE HANDICAPPED PARKING SPACES AT 118 WEST BARNARD STREET AND 404 NORTH DARLINGTON STREET AND TO ADOPT A NEW SECTION 104-34.1 TO PROHIBIT PARKING IN A PARKING SPOT DESIGNATED BY THE BOROUGH AS AN ELECTRIC CHARGING STATION IF THE MOTOR VEHICLE IS NOT CONNECTED TO THE CHARGING STATION.

BE IT ENACTED AND ORDAINED, and it hereby enacted by authority of the Council of the Borough of West Chester, as follows:

**SECTION 1.** Chapter 104 of the Code of the Borough of West Chester, titled, "Vehicles and Traffic," Section 104-32, titled, "Parking prohibited during certain hours" is hereby amended **TO REMOVE** the following:

Market St. St.	South	Thurs. 8:00-11:00 a.m.	Brandywine St. to Wayne St.
Market St. St.	North	Mon. 8:00-11:00 a.m.	Potter Alley to Brandywine St.
Poplar St.	West	Thurs. 8:00-11:00 a.m.	Miner St. to Barnard St.

**SECTION 2.** Chapter 104 of the Code of the Borough of West Chester, titled, "Vehicles and Traffic," Section 104-32, titled, "Parking prohibited during certain hours" is hereby amended **TO ADD** the following:

<u>Highway</u>	<u>Side</u>	<u>Days/Hours</u>	<u>Location</u>
Market St.	South	Thurs. 8:00-11:00 a.m.	Bradford Ave. to Wayne St.
Market St.	North	Mon. 8:00-11:00 a,m,	Potter Alley to Everhart St.
Poplar St.	West	Thurs. 8:00-11:00 a.m.	Market St. to Barnard St.

**SECTION 3.** Chapter 104 of the Code of the Borough of West Chester, titled, “Vehicles and Traffic,” Section 104-45, titled, “Special purpose parking zones established; parking otherwise prohibited,” is hereby amended **TO REMOVE** the following:

West Barnard Street	South	118 West Barnard Street	1 parking space for handicapped persons
Darlington Street	West	404 N. Darlington St.	1 parking space for handicapped persons

**SECTION 4.** Chapter 104 of the Code of the Borough of West Chester, titled, “Vehicles and Traffic,” shall be amended to add a new Section 104-34.1, titled, “Electric Vehicle Charging Station” which shall provide as follows:

**“§ 104-34.1. Electric Vehicle Charging Station.** The parking of motor vehicles in any parking spot that is designated by the Borough as an electric vehicle charging spot shall be limited to motor vehicles that are connected to the charging equipment. Once the motor vehicle is charged, the motor vehicle shall not remain parked in such designated electric charging spot.”

**SECTION 5. SERVABILITY.** If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts hereof. It is hereby declared as the intent of the Council of the Borough of West Chester that this Ordinance would have been adopted

had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included therein.

**SECTION 6. REPEALER.** All Ordinances or parts of Ordinances conflicting with any provisions of this Ordinance are hereby repealed insofar as the same affects this Ordinance.

**SECTION 7. EFFECTIVE DATE.** This Ordinance shall become effective upon enactment as provided by law.
