AN ORDINANCE OF THE BOROUGH OF WEST CHESTER, CHESTER COUNTY, PENNSYLVANIA, AMENDING THE CODE OF THE BOROUGH OF WEST CHESTER, SPECIFICALLY CHAPTER 77, TITLED "PARKING PROGRAM, RESIDENTIAL", SECTION 77-3(B)(1), TITLED "PERMIT AREA A" TO ADD THE 200 BLOCK OF LACEY STREET BETWEEN MAPLE ALLEY AND SOUTH FRANKLIN STREET TO PERMIT PARKING AREA A; AND TO AMEND CHAPTER 104, TITLED "VEHICLES AND TRAFFIC", SECTION 104-16, TITLED "STOP INTERSECTIONS ESTABLISHED" TO AUTHORIZE THE INSTALLATION OF A STOP SIGN AT THE INTERSECTIONS OF MINER STREET AND DARLINGTON STREET AND MINER STREET AND NEW STREET; AND SECTION 104-32, TITLED, "PARKING PROHIITED DURING CERTAIN HOURS" TO PROHIBIT PARKING ON SEVERAL SECTIONS OF THE SOUTH SIDE OF ROSEDALE AVENUE FROM SOUTH ADAMS STREET TO JOSEPH ALLEY ON WEDNESDAYS FROM 8:00 A.M. TO 11:00 A.M.

BE IT ENACTED AND ORDAINED, and it is hereby enacted by authority of the Council of the Borough of West Chester, as follows:

**SECTION 1.** Chapter 77 of the Borough of West Chester Code, titled, "Parking Program – Residential", Section 77-3(B)(1)(a) "Permit Area A" is hereby amended **TO ADD** the following block:

[21] Lacey Street from Maple Alley to South Franklin Street.

**SECTION 2.** Chapter 104 of the Code of the Borough of West Chester, titled, "Vehicles and Traffic," Section 104-16, titled "Stop intersections established" is hereby amended **TO ADD** the following:

<b>Highway</b>	<b>Through Highway</b>	<b>Direction of Travel</b>
Miner Street	New Street	Westbound
Miner Street	Darlington Street	Westbound

**SECTION 3.** Chapter 104 of the Code of the Borough of West Chester, titled, "Vehicles and Traffic," Section 104-32, titled, "Parking prohibited during certain hours" is hereby amended **TO ADD** the following:

<b>Highway</b>	<b>Side</b>	<b>Days/Hours</b>	<b>Between</b>
Rosedale Avenue	South	Wed./8:00 a.m.- 11:00 a.m.	From South Adams Street to Joseph Alley where signs indicate

**SECTION 4. SEVERABILITY.** If any sentence, clause, section, or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts hereof. It is hereby declared as the intent of the Council of the Borough of West Chester that this Ordinance would have been adopted had such unconstitutional, illegal, or invalid sentence, clause, section or part thereof not been included therein.

**SECTION 5. REPEALER.** All Ordinances or parts of Ordinances conflicting with any provisions of this Ordinance are hereby repealed insofar as the same affects this Ordinance.

**SECTION 6. EFFECTIVE DATE.** This Ordinance shall become effective upon enactment as provided by law.
