Proposed work: Front Façade; Replacement of existing exterior stair treads with new concrete stair treads. Also proposed; the removal of the stone veneer from exterior stair and base of building – to be replaced with stucco on lath. Also proposed; changing the existing white paint of the existing white windows and trim to black. Rear of Building; Installation of wood stockade fence to both sides of rear yard. Also proposed; removing aluminum ramp in rear yard and replacing with wooden steps. Also proposed; installation of picket fence along top of retaining wall running parallel to the rear alley.
- c. 2020-15: 128 East Gay St – David Katz / David Katz Gallery
Proposed work: Replacement of existing two-sided hanging sign on front façade of building. The sign will utilize the existing bracket and will have no new illumination.
- d. 2020-16: 44 West Gay St – Adam Loew / 44 West
Proposed work: Installation of a new ground sign adjacent to the sidewalk and new building.
- e. 2020-17: 44 West Gay St Suite 2 – David Trout / Sedona Taphouse
Proposed work: Installation of 4 new signs. 3 exterior signs on the front and side facades and one interior sign. The exterior signs to be lit with interior LEDs. Also proposed is an exterior patio awning.

**How to Engage in Public Comment During a
Borough Council or Committee Meeting**

Public Comment is heard at three different points during Borough Council meetings:

- **BEFORE CONSIDERATION OF ITEMS ON THE AGENDA** The public is permitted to make public comment on any matter not on the agenda. You will have three minutes to make your statement, unless the President or Chair has announced otherwise, so please come prepared.
- **BEFORE ACTION** on a motion or an agenda item. Public Comment at this stage is limited to the item under discussion. As above, please keep your comments to three minutes.
- **AFTER ACTION ON ALL AGENDA ITEMS HAVE BEEN ACTED.** Public Comment is open to any legitimate item of business that can be considered by Council or the Committee. Again, please keep your comments brief.

How to make a comment:

- The President or Chair will announce an opportunity for public comment, either on a specific issue or generally, depending on where we are in the agenda (see above).
- After you are recognized by the President or Chair, come to the microphone, and state your name and address for the record.
- You may then make your comment or ask your question. As noted above, you will have three minutes to make your statement, unless the President or Chair has announced otherwise.
