

ORDINANCE NO.10– 2019

BOROUGH OF WEST CHESTER

CHESTER COUNTY, PENNSYLVANIA

AN ORDINANCE OF THE BOROUGH OF WEST CHESTER, CHESTER COUNTY, PENNSYLVANIA, AMENDING THE CODE OF THE BOROUGH OF WEST CHESTER, SPECIFICALLY CHAPTER 3, TITLED “ADMINISTRATIVE CODE,” SECTION 3-37, TITLED “ADMINISTRATIVE BOARD AND COMMISSIONS,” TO REMOVE SUBSECTION L., TITLED “BUILDING, HOUSING AND FIRE CODES APPEALS BOARD” AND SECTION 3-38, TITLED “ADVISORY BOARDS AND COMMISSIONS” TO AMEND SUBSECTION 3-38.K(2) TO EXPAND THE NUMBER OF PEOPLE ON THE WEST CHESTER LIBRARY BOARD FROM 11 TO 13 MEMBERS.

BE IT ENACTED AND ORDAINED, and it is hereby enacted by authority of the Council of the Borough of West Chester, as follows:

SECTION 1. Chapter 3 of the Code of the Borough of West Chester, titled “Administrative Code,” Section 3-37, titled, “Administrative boards and commissions”, is amended to delete Subsection 3-37.L., titled, “Building, Housing and Fire Codes Appeals Board” entirely.

SECTION 2. Chapter 3 of the Code of the Borough of West Chester, titled “Administrative Code,” Section 3-38, titled, “ Advisory boards and commissions”, is amended by amending Subsection 3-38.K(2) titled, “Library Board”, as follows:

“(2) The Library Board shall consist of thirteen regular members, a majority of which shall be full-time residents and qualified electors of the Borough and be appointed by the Borough Council for three-year terms.”

SECTION 3. SEVERABILITY. If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts hereof. It is hereby declared as the intent of Council of the Borough of West Chester that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included therein.

SECTION 4. REPEALER. All Ordinances or parts of Ordinances conflicting with any provision of this Ordinance are hereby repealed insofar as the same affects this


Ordinance.
