

ORDINANCE NO. 01-2022

BOROUGH OF WEST CHESTER

CHESTER COUNTY, PENNSYLVANIA

AN ORDINANCE OF THE BOROUGH OF WEST CHESTER, CHESTER COUNTY, PENNSYLVANIA, AMENDING THE CODE OF THE BOROUGH OF WEST CHESTER, SPECIFICALLY CHAPTER 104 TITLED "VEHICLES AND TRAFFIC," SECTION 104-45 TO ADD A HANDICAPPED PARKING SPACE AT 3 SOUTH BRANDYWINE STREET AND TO REMOVE A HANDICAPPED PARKING SPACE AT 215 WEST LAFAYETTE STREET.

BE IT ENACTED AND ORDAINED, and it hereby enacted by authority of the Council of the Borough of West Chester, as follows:

SECTION 1. Chapter 104 of the Code of the Borough of West Chester, titled, "Vehicles and Traffic," Section 104-45, titled, "Special purpose parking zones established; parking otherwise prohibited," is hereby amended **TO ADD** the following:

Highway	Side	Location	Authorized Purpose or Vehicle
Brandywine Street	East	3 S. Brandywine St.	1 parking space for handicapped persons

SECTION 2. Chapter 104 of the Code of the Borough of West Chester, titled, "Vehicles and Traffic," Section 104-45, titled, "Special purpose parking zones established; parking otherwise prohibited," is hereby amended **TO REMOVE** the following:

Highway	Side	Location	Authorized Purpose or Vehicle
Lafayette Street	North	215 W. Lafayette St.	1 parking space for handicapped persons

SECTION 3. SEVERABILITY. If any sentence, clause, section, or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts hereof. It is hereby declared as the intent of the Council of the Borough of West Chester that this Ordinance would have been adopted had such unconstitutional, illegal, or invalid sentence, clause, section or part thereof not been included therein.

SECTION 4. REPEALER. All Ordinances or parts of Ordinances conflicting with any provisions of this Ordinance are hereby repealed insofar as the same affects this Ordinance.

SECTION 5. EFFECTIVE DATE. This Ordinance shall become effective upon enactment as provided by law.


