

ORDINANCE NO. 05 – 2022

BOROUGH OF WEST CHESTER

CHESTER COUNTY, PENNSYLVANIA

AN ORDINANCE OF THE BOROUGH OF WEST CHESTER, CHESTER COUNTY, PENNSYLVANIA, AMENDING THE CODE OF THE BOROUGH OF WEST CHESTER, SPECIFICALLY CHAPTER 104, TITLED “VEHICLES AND TRAFFIC,” SECTION 104-45 TO REMOVE A HANDICAPPED PARKING SPACE AT 137 EAST MINER STREET AND 124 EAST MINER STREET; AND TO ADD A HANDICAPPED PARKING SPACE AT 144 EAST MINER STREET, ON THE 300 BLOCK OF LINDEN STREET BETWEEN SRGT. YARNALL ALLEY AND SOUTH PENN STREET AND AT 132 EAST MINER STREET.

BE IT ENACTED AND ORDAINED, and it is hereby enacted by authority of the Council of the Borough of West Chester, as follows:

SECTION 1. Chapter 104 of the Code of the Borough of West Chester, titled, “Vehicles and Traffic,” Section 104-45, titled, “Special purpose parking zones established; parking otherwise prohibited,” is hereby amended **TO DELETE** the following:

Highway	Side	Location	Authorized Purpose or Vehicle
Miner Street	North	137 East Miner Street	1 parking space for handicapped persons
Miner Street	South	124 East Miner Street	1 parking space for handicapped persons

SECTION 2. Chapter 104 of the Code of the Borough of West Chester, titled, “Vehicles and Traffic,” Section 104-45, titled, “Special purpose parking zones established; parking otherwise prohibited,” is hereby amended **TO ADD** the following:

Highway	Side	Location	Authorized Purpose or Vehicle
Miner Street	South	132 East Miner Street	1 parking space for handicapped persons
Miner Street	South	144 East Miner Street	1 parking space for handicapped persons
Linden Street	South	300 Block of Linden Street between Srgt. Yarnall Alley and South Penn Street	1 parking space for handicapped persons

SECTION 3. SEVERABILITY. If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts hereof. It is hereby declared as the intent of Council of the Borough of West Chester that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included therein.

SECTION 4. REPEALER. All Ordinances or parts of Ordinances conflicting with any provision of this Ordinance are hereby repealed insofar as the same affects this Ordinance.


SECTION 5. EFFECTIVE DATE. This Ordinance shall become effective upon enactment as provided by law.
