

ORDINANCE NO. 14 - 2023

BOROUGH OF WEST CHESTER

CHESTER COUNTY, PENNSYLVANIA

AN ORDINANCE OF THE BOROUGH OF WEST CHESTER, CHESTER COUNTY, PENNSYLVANIA, AMENDING THE CODE OF THE BOROUGH OF WEST CHESTER, CHAPTER 104, TITLED "VEHICLES AND TRAFFIC", SECTION 104-55.1, TITLED "UNLAWFUL OPERATION OF BUSINESS" TO DELETE THE WORD "BUSINESS".

BE IT ENACTED AND ORDAINED, and it is hereby enacted by authority of the Council of the Borough of West Chester, as follows:

SECTION 1. Chapter 104 of the Code of the Borough of West Chester, titled, "Vehicles and Traffic," Sections 104-55.1.A and 104-55.1.B titled, "Unlawful Operation of Business" shall be amended to state as follows:

"A. It shall be unlawful and a violation of this article for any person, owner or operator of a passenger and/or commercial motor vehicle or trailer to operate a food truck from any parking space adjacent to any parking meter established under this article or on any public right-of-way, except in the following designated locations:

Name of Street	Side	Location
Church Street	West	From Sharpless Street to Rosedale Avenue
University Avenue	South	From High Street to Church Street

B. Any person, owner or operator of a food truck or trailer that operates from the parking spaces permitted in § 104-55.1A above shall first obtain a permit pursuant to Chapter 80 of the Borough Code and shall comply with the regulations in this § 104-55.1."

SECTION 2. SEVERABILITY. If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts hereof. It is hereby declared as the intent of Council of the Borough of West Chester that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included therein.


SECTION 3. REPEALER. All Ordinances or parts of Ordinances conflicting with any provision of this Ordinance are hereby repealed insofar as the same affects this Ordinance.

SECTION 4. EFFECTIVE DATE. This Ordinance shall become effective upon enactment as provided by law.


